Contributions or gifts to NAVA are not deductible as charitable contributions for federal income tax purposes. However, they may be tax deductible as ordinary and necessary business expenses subject to restrictions imposed as a result of association lobbying expenses. As required by Section 6033 of the Internal Revenue Code, NAVA estimates that the nondeductible portion of 2018 dues paid by Oregon Operators, Washington Operators, and Associates - the portion which is allocable to lobbying - is 100%. NAVA estimates that the nondeductible portion of 2018 dues paid by Alaska Operators- the portion which is allocable to lobbying - is -0.%. Therefore, only dues less that percentage may be deducted by you as an ordinary and necessary business expense for your 2018 tax year.
